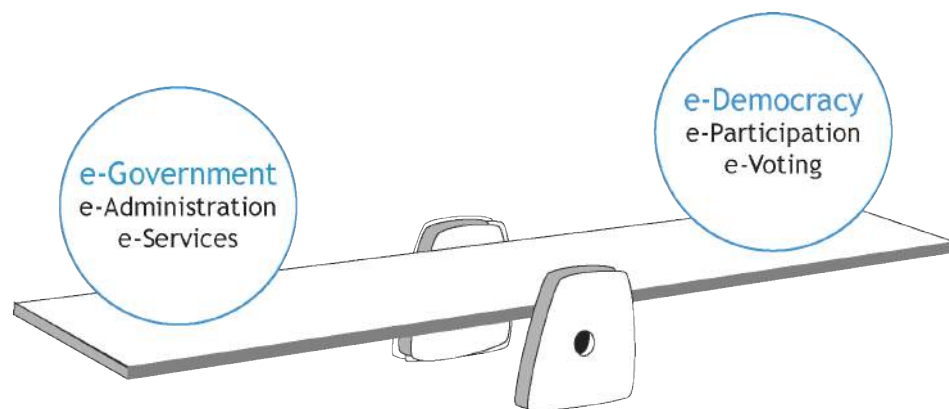

- Wide network of the international experts – all practitioners with hands-on experience





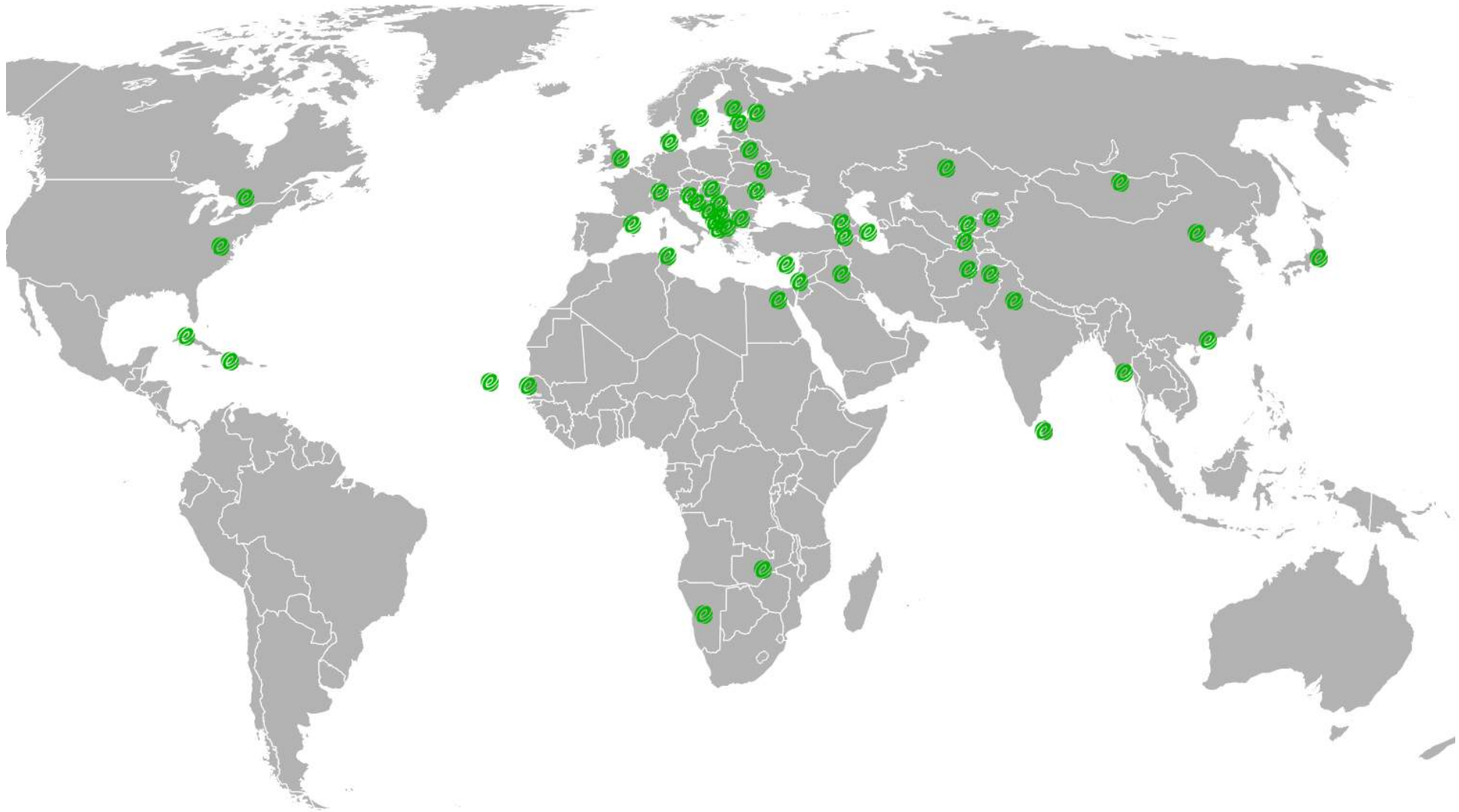

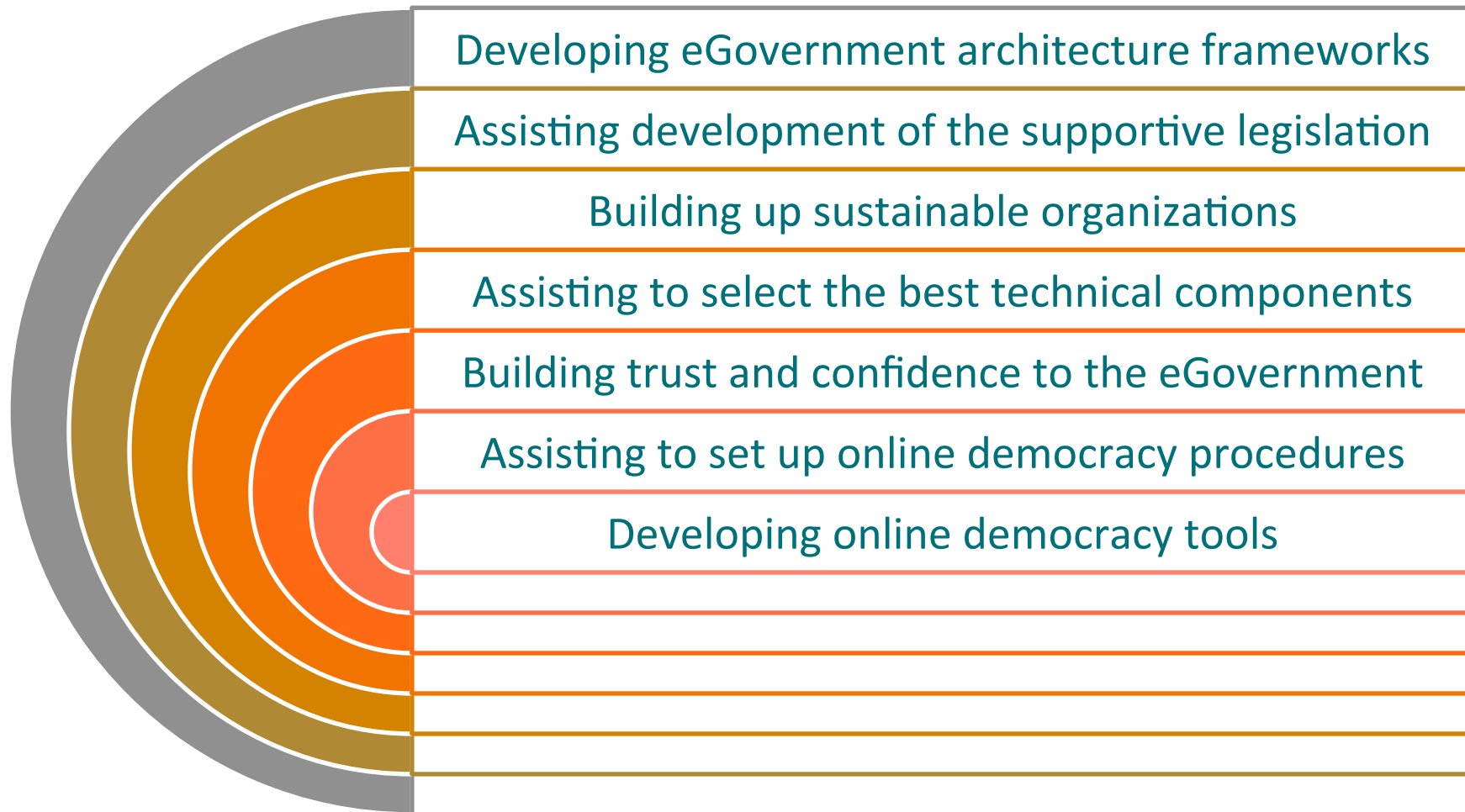
